There is free street parking as well as several adjacent lots.

## **FARMERS MARKET RULES OF OPERATION**

(Please keep this for your records)

1. Location: Copernicus Center Annex located a 5216 W. Lawrence Ave., 60630
2. Hours of operation for the markets will be from 10am until 2pm. Set up time is between 9am & 10am. Vendors are expected to remain until the end of the market at 2pm.
3. Spaces: All spaces will be assigned by the Jefferson Park Sunday Market staff. Tables will be included to help facilitate layout & ease congestion during load in/out. If you cannot use a table, please note that. Spaces may change market to market. A no show may result in your future exclusion from this market.
- 4 Compliance with Local, State, and Federal Laws: All producers are responsible for obtaining all necessary County or State health and/or other permits and are responsible for compliance with all State and Federal food and drug laws including proper labeling.
5. Scales: If goods are offered for sale by weight, the producer's scale must be in accordance with the local county requirements and with those established standards as set by the State of Illinois.
6. Sales Tax: Each producer is responsible for the reporting of and the payment to the Illinois Department of Revenue of all required taxes resulting from the sales made at the Jefferson Park Sunday Market.
7. Damage and cleaning: Any excessive damage done to the Copernicus Center facility or property shall be billed to the client for either replacement or repair.
  - a. Any excessive mess (at the determination of the staff) done by children or adults resulting in extra cleaning of Copernicus Center and its property shall be charged an additional cleaning fee of \$100.00 which is not refundable.
  - b. Any additional damage to the facility and its contents/property shall be charged accordingly.
  - c. ONLY painter's tape can be used on the painted walls.
8. Cleanup: Each producer is responsible for the removal of all waste and garbage from his or her own space at the closing hour of each market day. Failure to do so may result in suspension from the market.
9. Open flames of any kind are PROHIBITED.
10. Smoking: Producers and their associates may NOT smoke/vape in the sales area during market hours.
11. Parking: There will be parking available for vendors in the Copernicus Center lot.
12. Vendors are NOT allowed to sell any alcoholic beverages. Note that bar will open at 11am, and beverages will be available there.
